- Proposal Submission Time:** Proposal must be submitted within 16:00 p.m. (Bangladesh Standard Time) 18th April, 2024.
- Required Content of the Quotation:** Quotation must be submitted as per prescribed form as instructed above
- Complete proposal/offer must be signed with date by the authorized representative of the company.
- Quotation Validity:** The Quotation shall be valid for 90 calendar days from the Quotation submission/ closing date.
- Manipulation or any kind of unusual approach or failure to submit the proposal/offer within stipulated time frame will be treated as "Disqualification" to attend in the bidding.

 - Price:** Rate should be quoted in BDT with figure & words including VAT and all applicable Taxes as per Govt. rules. If supplier submits the Mushok Challan 6.3 with the Bill VAT will not be deducted from the bill. Tax will be as per govt. rules. Govt. Challan will be provided to supplier for AIT with Certificate.
